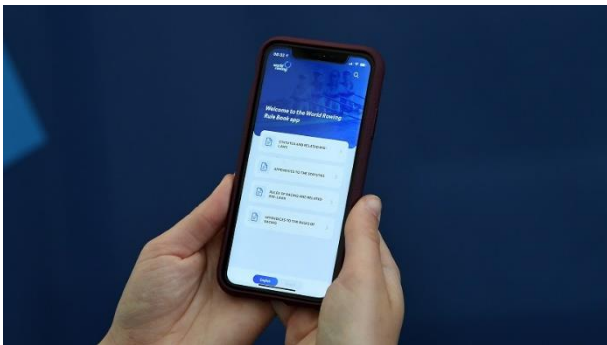


ATHLETE LANE SELECTION

One of our newest innovations at World Rowing Events is Athlete Lane Selection (ALS). The ALS process allows crews to choose the lanes that they will use for racing. While it was first tested at a World Cup in 2019, a fuller test was scheduled for this year. The first plan was to use the Poznan World Cup 2 as a trial for ALS. After success in Poznan, the decision was made to further test ALS at World Cup 3

in Lucerne. World Rowing is now gathering feedback on these trials to determine the future of ALS.

RULES UPDATE - 2023

World Rowing has a standing Rules Working Group (RWG) that is tasked with maintaining the Rules of Racing, the Bye-Laws and Rules related Appendices. There is another working group, the Governance Working Group that is responsible for the Statutes and their related Appendices.

The initial 2023 update of the Rules, Bye-Laws and Regulations was approved by the World Rowing Council earlier this year and the website and World Rowing Rules App has now been updated. Later this year, the Umpiring Commission will be introducing an on-line, on-demand education network. The initial module will cover the 2023 Rules Updates. More information will be made available when the system becomes available.
